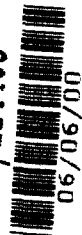



ASSIGNMENT


