

Versicor, Inc., a corporation organized under the laws of Delaware, located at 34790 Ardentech Court, Fremont, California 94555, hereinafter called the ASSIGNOR;  
and

Pharmacia & Upjohn Company, a corporation organized under the laws of Delaware, located at 95 Corporate Drive, Bridgewater, New Jersey 08807, hereinafter called the ASSIGNEE.

**WHEREAS:**

(A) The ASSIGNOR is the registered assignee and/or applicant of the patents/patent applications that are set forth in the list below.

(B) In view of valuable consideration, receipt of which is hereby acknowledged, ASSIGNOR hereby assigns and transfer unto ASSIGNEE, its entire interest in and the full and exclusive right to the inventions or discoveries (herein INVENTIONS) as claimed in the patent applications (herein APPLICATIONS) identified in Schedule A attached hereto, the APPLICATIONS and all related applications (that is, divisions, reissues, continuations, and extensions of the APPLICATIONS) and all counterparts in other countries and any and all Letters Patent (and certificates of invention or similar certificates) (herein PATENTS) which may be granted based upon the INVENTIONS, or the APPLICATIONS or such related applications or counter parts in other countries; said transfer and assignment being applicable throughout the world.

(D) ASSIGNOR agrees that it will communicate to ASSIGNEE, or its representatives, any facts known to it respecting the INVENTION; sign all lawful papers; execute all divisional, continuation, substitution, renewal and reissue applications relating to the APPLICATIONS; execute all necessary assignment papers to cause any and all of the PATENTS to be issued to ASSIGNEE; make all rightful oaths; and generally do everything reasonably possible, to the extent reasonably requested by ASSIGNEE, to aid ASSIGNEE, its successors and assigns, to obtain issuance of the APPLICATIONS. 
