
FIRST: That Article FIRST of the Certificate of Incorporation be, and hereby is, amended to read in its entirety as follows:

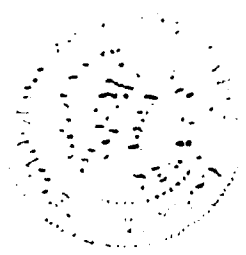
"FIRST: The name of the corporation is Infineon Technologies North America Corp.
