**WHEREAS**, We, **BEAT NÄF**, a citizen of Switzerland residing at REBACKERSTRASSE 18a, CH-8645 JONA, SWITZERLAND, and **LARS WEISIGK**, a citizen of Switzerland residing at BRÜNNELIHÖHESTASSE 1, CH-8400 WINTERTHUR, SWITZERLAND (hereinafter referenced as ASSIGNORS), have invented a certain new and useful invention entitled **AN APPARATUS FOR THE ENTRY OF A FIBER BAND INTO A STRETCH MACHINE**, for which an application for Letters Patent of the United States has been filed in the United States Patent and Trademark Office;
