WHEREAS, we, Grant S. Quam, 891 Southeast 44th Avenue, Owatonna, Minnesota 55060, Thomas A. such applications or patents, by giving testimony in any proceedings or transactions involving such applications or patents.

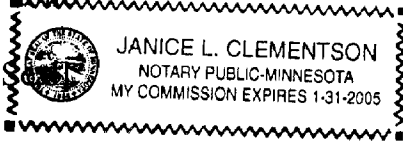

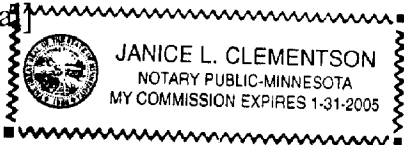
