

I do hereby covenant for myself and my legal representatives, and agree with REBORN PRODUCTS CO., INC. and its legal representatives, that I have granted no license to make or sell the said invention, that prior to the execution of this deed my right, title and interest in


the said invention has not been encumbered, that I then had good right and title in and to the invention and that I have not executed and will not execute any instrument in conflict therewith.
