ASSIGNMENT

WHEREAS, Glenn W. Travis, hereinafter called the "Assignor," has made the invention described in the United States patent application entitled METHOD AND APPARATUS FOR WAFER CARRIER IN-PROCESS CLEAN AND RINSE, executed by Assignor on the same date as this Assignment;


