NOW THEREFORE, in consideration of the sum of Ten Dollars (\$10.00) lawful money of the United States from ASM MICROCHEMISTRY OY to the undersigned duly authorized representative of FORTUM OIL AND GAS OY in hand paid, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, FORTUM OIL AND GAS OY has sold, assigned and transferred and does hereby sell, assign, and transfer the full and exclusive right to said invention in the United States of America and its territories, dependencies, and possessions, and the entire right, title, and interest in and to the application and in and to any and all Letters Patent(s) which may be granted therefor in the United States of America and its territories, dependencies and possessions, and in and to any and all divisions, reissues, continuations, renewals, and extensions thereof for the full term or terms for which the same may be granted, to be held and enjoyed by ASM MICROCHEMISTRY OY, its successors and assigns, to the same extent that

this right, title and interest would have been held and enjoyed by FORTUM OIL AND GAS OY, if this assignment and sale had not been made.

IN ADDITION, FORTUM OIL AND GAS OY hereby authorizes and requests the Commissioner of Patents and Trademarks to issue all such Letters Patent as may issue on the application to ASM MICROCHEMISTRY OY, in accordance with this instrument.

FORTUM OIL AND GAS OY hereby represents and warrants that there are no rights or interests outstanding which are inconsistent with the interest granted to ASM MICROCHEMISTRY OY by this instrument, and that FORTUM OIL AND GAS OY will not execute any instrument or grant or transfer of any rights or interests which is inconsistent with the interest granted to ASM MICROCHEMISTRY OY by this instrument.

FORTUM OIL AND GAS OY binds itself and its heirs, executors, administrators, employees, and legal representatives, as the case may be, to execute and deliver to said ASM MICROCHEMISTRY OY, its successors and assigns, any further documents or instruments and do any and all further acts that may be deemed necessary by ASM MICROCHEMISTRY OY, its successors and assigns, to file applications for the above improvements and invention in the United States of America, and that may be necessary to vest in ASM MICROCHEMISTRY OY, its successors and assigns, the interest herein conveyed, or intended to be conveyed, and to enable said interest to be recorded in the United States of America.

FORTUM OIL AND GAS OY further covenants and agrees, in consideration of the premises, that it, its executors, and administrators will, at any time upon request, communicate to ASM MICROCHEMISTRY OY, its successors and assigns, any facts relating to said invention or improvements, and the history thereof, known to it or its executors and administrators, and that it will testify, or cause its employees to testify, as to the same in any interference or other proceeding when requested to do

so by ASM MICROCHEMISTRY OY, its successors and assigns.

The undersigned duly authorized representative of FORTUM OIL AND GAS OY has reviewed the evidentiary documents reflecting the chain of title to the application, and certifies to the best of his knowledge and belief that FORTUM OIL AND GAS OY presently is assignee of the entire right, title and interest in and to the application.

The undersigned duly authorized representative of FORTUM OIL AND GAS OY, whose title is supplied below, is empowered to act on behalf of FORTUM OIL AND GAS OY.
