

1. They are the President and Secretary, respectively, of Siliscape, Inc., a California corporation (the "Corporation");

2. Article I of the Articles of Incorporation of this Corporation is hereby amended in full to read as follows:

**"ARTICLE I. NAME: The name of this Corporation is INVISIO, INC."**

3. The foregoing amendment of the Articles of Incorporation has been duly approved by the board of directors of the Corporation.

4. The foregoing amendment of the Articles of Incorporation has been duly approved by the required vote of shareholders of the Corporation in accordance with Section 902 of the Corporations Code. The total number of outstanding shares of the Corporation is 4,269,438 shares of Common Stock, 622,999 shares of Series AA Preferred Stock, 3,796,358 shares of Series BB Preferred Stock and 5,286,527 shares of Series CC Preferred Stock. The number of shares voting in favor of the amendment equaled or exceeded the vote required. The percentage vote required was more than 50% of the outstanding shares. No shares of Series BB1 and Series CC1 Preferred stock have issued, and none are outstanding.

We further declare under penalty of perjury under the laws of the State of California that the matters set forth in this certificate are true and correct of our own knowledge.

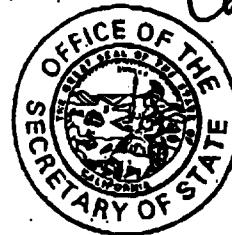
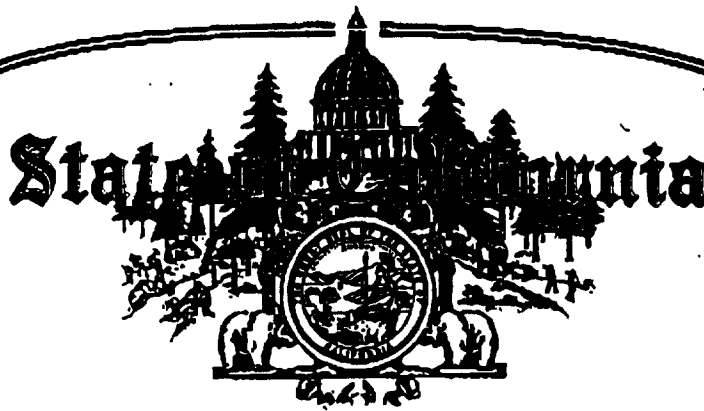

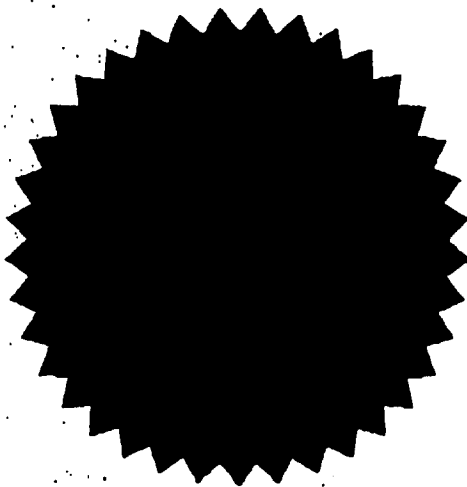
