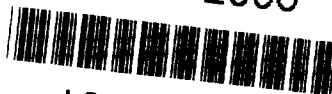



## **ASSIGNMENT**

WHEREAS, I, Masakazu Okimoto of ASCII CORPORATION, 33-10, Yoyogi 4-chome, Shibuya-ku, Tokyo, Japan, have invented certain improvements in a controller for video games, for which I have executed an application for Letters Patent of the United States on the date I executed this Assignment as hereinafter set forth.

CORPORATION and OPUS CORPORATION, its successors and assigns.

Further, I agree that I will communicate to the said ASCII CORPORATION and OPUS CORPORATION, or its representatives any facts known to me respecting said invention, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuation, substitution, renewal and reissue applications, execute all necessary assignment papers to cause any and all of said Letters Patent to be issued to the said ASCII CORPORATION and OPUS CORPORATION, make all rightful oaths and generally do everything possible to aid the said ASCII CORPORATION and OPUS CORPORATION, its successors and assigns, to obtain and enforce proper protection for said invention in the United States and in any and all foreign countries.
