ASSIGNMENT

WHEREAS, WE, Damon Delorenzis And Richard J. 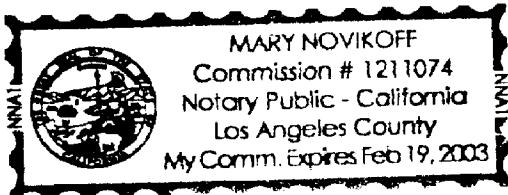
