BILL OF SALE AND GENERAL ASSIGNMENT

(The B.F.Goodrich Company)

This BILL OF SALE AND GENERAL ASSIGNMENT ("Bill of Sale"), dated as of March 31, 2000, by THE B.F.GOODRICH COMPANY, a New York corporation ("Member"), in favor of APT, LLC, a Delaware limited liability company ("Company").

BACKGROUND

WHEREAS, Member and Advanced Polymer Technologies, L.L.C. have entered into that certain Limited Liability Company Agreement dated as of March 31, 2000 ("LLC Agreement"), pursuant to which Member has agreed to contribute to the Company all of Member's right, title and interest in and to certain of Member's assets. Capitalized terms used but not otherwise defined herein shall have the respective meanings assigned to them in the LLC Agreement.

NOW, THEREFORE, in consideration of the foregoing premises, and the mutual promises, covenants and agreements contained in the LLC Agreement, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Member does hereby sell, convey, transfer, assign, convey and deliver to the Company and its successors and assigns forever, free and clear of all encumbrances, all of Member's right, title and interest in and to those assets identified in Schedule A-2 to the LLC Agreement that can be conveyed pursuant to this Agreement. Such assets are described on Schedule A hereto. Member shall promptly execute, deliver, record and file any and all releases, affidavits, -waivers and other documents, and take any additional actions that the Company may reasonably request Member to execute, deliver, record, file or take in connection with the implementation of this Agreement.

The Company hereby accepts all right, title and interest in and to such assets and hereby assumes all Member's obligations and liabilities with respect thereto.

This Agreement is for the sole and exclusive benefit of Member and the Company and their successors and assigns and nothing herein is intended or shall be construed to confer upon any person other than Member and the Company or their successors and assigns any right, remedy or claim under or by reason of this Agreement or any term, covenant or condition hereof. This Agreement shall be governed by and construed in accordance with the laws of the State of Delaware and may only be amended and modified by written instrument executed by each of the parties hereto. This Agreement may be executed in two or more counterparts, each of which shall be deemed to be an original and all of which shall together constitute one and the same instrument.

IN WITNESS WHEREOF, each of the undersigned has caused this Bill of Sale and General Assignment to be duly executed on its behalf on the date first written above.
