Further, I agree to execute all papers and to give such lawful testimony and to perform such other lawful acts as said Impact Sports, Inc., its successors and assigns may require to enable it or them to procure Letters Patent on said invention or reissues or extensions thereof in the United States of America and/or in any foreign country, and/or to hold, enforce or convey said Letters Patent, reissues or extensions.


