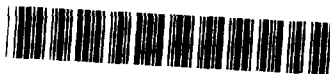

## PATENT

ASSIGNMENT

WHEREAS, I, Monier Maher of 407 N. Taylor, #302, St. Louis, Missouri 63108, have invented certain new and useful improvements for a *METHOD AND DEVICE FOR DISTRIBUTING BANDWIDTH* for which I have this same day executed an application for Letters Patent in the United States identifying me as one of the inventors thereof (said application being identified as Howell & Haferkamp, L.C., Docket 16541-2775); and
