WHEREAS, we, the undersigned inventors having our residences as set forth below, have invented a new invention for

AUTOMATIC EMERGENCY CALL SYSTEM FOR MOTOR VEHICLES

as described and set forth in an application for United States Letters Patent, U.S. Serial No. 09/546,071 filed April 10, 2000; and
