## DEED OF ASSSIGNMENT

Whereas, we, **Boen Ho O and Hans WESTMIJZE**, have invented certain new and useful improvements in **EMULSIONS OF PEROXYESTERS**, for which an application for United States Letters Patent has been filed; and

Whereas, Akzo Nobel NV, a corporation organized and existing under and by virtue of the laws of The Netherlands, with its principal office and place of business at Arnhem, The Netherlands, is desirous of acquiring the entire right, title and interest in and to said application and the invention therein disclosed, described and claimed; in any and all continuations and divisions of said application; in any and all Letters Patent of the United States of America which may issue from said application or continuations or divisions thereof, including any and all reissue or reissues, of such Letters Patent; and, in any and all foreign applications corresponding to said application or applications, and such foreign Letters Patent which may issue therefrom;

Now, THEREFORE, TO ALL WHOM IT MAY CONCERN, BE IT KNOWN, that for and in consideration of the sum of one dollar (\$1.00) and other good and valuable consideration to us in hand paid by the said Akzo Nobel NV, the receipt whereof is hereby acknowledged, we the said **Boen Ho O and Hans WESTMIJZE** have bargained, sold, assigned, transferred and set over, and by these presents do hereby bargain, sell, assign, transfer and set over unto the said Akzo Nobel NV, its successors and assigns the entire right, title and interest in and to said application for Letters Patent, and the invention therein disclosed, described and claimed; in any and all continuations and divisions of said application; in any and all Letters Patent of the United States of America which may issue from said application or continuations or divisions thereof, including any and all reissue or reissues of such Letters Patent; and, in any and all foreign applications corresponding to said application or applications, and such foreign Letters Patent which may therefrom; the Letters Patent which may issue for said invention to be held and enjoyed by the said Akzo Nobel NV, for its own use and behoof, and, for the use and behoof of its successors, assigns or other legal representatives, to the full end of the term of terms for which said Letters Patent may be granted, reissued or extended, as fully and entirely as the same would have been held and enjoyed by us if this assignment and sale had not been made.

And we hereby authorize the Commissioner of Patents to issue any and all Letters Patent of the United States of America for said invention, or resulting from said application or applications therefor, to the said Akzo Nobel NV, as the

assignee of the entire right, title and interest in and to the said application and invention.

And we further hereby assign unto said Assignee, its successors and assigns the priority rights deriving from said application or applications and grant the rights to file foreign applications corresponding thereto, whether claiming convention priority or not.

And we further covenant and agree that we will at any time, upon request, execute and deliver any and all papers that may be necessary or desirable to perfect the title to said invention, said applications, whether foreign or domestic, or any Letters Patent that may be granted therefor, in Akzo Nobel NV, its successors, assigns or other legal representatives, and that if the said Akzo Nobel NV, its successors, assigns or other legal representatives desire to secure a reissue or extensions or division of said Letters Patent, we will, upon request, sign all papers, make all rightful oaths, and do all legal acts necessary and requisite for the application for such reissue, extension or division, and the procuring thereof.

And we further covenant and agree that we will at any time, upon request, communicate to Akzo Nobel NV, its successors, assigns or other legal representatives, any facts relating to the said invention and Letters Patent, or the history thereof known to us, and will testify as to the same in any interference or litigation when requested to do so.
