



**ASSIGNMENT**

WHEREAS, YASUTAKA ISHII, residing at 19-21, Besshohonmachi, Takatsuki-shi, Osaka, Japan, is a co-owner by previous assignment, dated October 2, 1998 (recorded at Reel 010049, Frames 691-694), of the right, title and interest of the inventors Yasutaka ISHII, Tatsuya NAKANO and Naruhisa HIRAI in and to an invention for ADAMANTANE DERIVATIVES AND PROCESS FOR PRODUCING THEM, for which an application for Letters Patent in the United States was executed on October 2, 1998, and assigned Serial No. 09/180,478, and is a co-owner of the right, title and interest in and to said application in the United States by said previous assignment;

WHEREAS, DAICEL CHEMICAL INDUSTRIES, LTD., a corporation organized and existing under and by virtue of the laws of Japan, having a place of business at 1, Teppo-cho, Sakai-shi, Osaka 590-8501 Japan, is desirous of acquiring the entire right, title and interest in and to the said application and the invention therein described and claimed and any Letters Patent that may be issued upon said application;

NOW, THEREFORE, for and in consideration of the sum of Ten Dollars (\$10.00) lawful money of the United States and other valuable considerations, to me in hand paid, the receipt of and sufficiency whereof are hereby acknowledged, said YASUTAKA ISHII has sold, assigned and transferred and does hereby sell, assign and transfer unto DAICEL CHEMICAL INDUSTRIES, LTD., its successors and assigns, his entire right, title and interest in and to the said application and the invention therein contained, including the right to apply for any Letters Patent in the United States of America on said invention and

including the right to claim the priority of the date of filing in the United States and any Letters Patent that may issue thereon, or therefor, in the United States and all reissues, extensions, renewals, divisions and continuations thereof, to the full end of the term or terms for which said Letters Patent may be issued, to be held and enjoyed by DAICEL CHEMICAL INDUSTRIES, LTD., its successors and assigns the same as it would have been held and enjoyed by YASUTAKA ISHII, if this assignment and sale had not been made.

AND, YASUTAKA ISHII hereby authorizes and requests the Commissioner of Patents and Trademarks to issue all such Letters Patents to DAICEL CHEMICAL INDUSTRIES, LTD., in accordance with this instrument of assignment.

YASUTAKA ISHII hereby represents and warrants that there are no rights or interests outstanding inconsistent with the rights and interest granted herein and that YASUTAKA ISHII will not execute any instrument or grant or transfer any rights or interests inconsistent therewith, and YASUTAKA ISHII binds himself and his heirs, executors, administrators, employees and legal representatives, as the case may be, to execute and deliver to DAICEL CHEMICAL INDUSTRIES, LTD., its successors and assigns, any further documents or instruments and do any and all further acts that may be deemed necessary by DAICEL CHEMICAL INDUSTRIES, LTD., its successors and assigns to file applications for the said invention in any country where it may elect to file such applications, and that may be necessary to vest in DAICEL CHEMICAL INDUSTRIES, LTD., its successors and assigns, the title herein conveyed, or intended so to be, and to enable such title to be recorded

in the United States and foreign countries where such application or applications may be filed.

AND, YASUTAKA ISHII further covenants and agrees, in consideration of the premises, that he, his executors and administrators will, at any time upon request, communicate to DAICEL CHEMICAL INDUSTRIES, LTD., its successors and assigns, any facts relating to the said invention and the history thereof, known to it or its successors and assigns, and that he will testify as to the same in any interference or other proceeding when requested to do so by DAICEL CHEMICAL INDUSTRIES, LTD., its successors and assigns.

The undersigned hereby grants the law firm of Birch, Stewart, Kolasch & Birch, LLP the power to insert on this Assignment any further identification which may be necessary or desirable in order to comply with the rules of the U.S. Patent and Trademark Office for recordation of this document.
