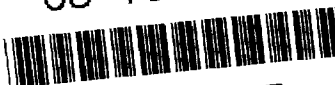

ASSIGNMENT

WHEREAS, I, Niel Mazurek, of Huntingdon Valley, County of Montgomery, and State of Pennsylvania, have made new and useful improvements in CONTINUOUS LEVEL MEASUREMENT FOR GREASE SEPARATOR;

WHEREAS, Josam Company, a corporation duly organized and existing under the laws of the State of Florida, having a place of business at 2501 S.
