THIS IS THE LAST WILL of me, LESLIE GEORGE DUTCHBURN, of the City of North York in the Municipality of Metropolitan Toronto, Province of Ontario.

- I. I REVOKE all former wills and other testamentary dispositions made by me.
- II. I APPOINT my wife, KATHRYN ANN DUTCHBURN, of the City of North York in the Municipality of Metropolitan Toronto, to be the Executor and Trustee of this my Will. If the said KATHRYN ANN DUTCHBURN shall have predeceased me or shall survive me but die before the trusts hereof shall have terminated or shall be unable or unwilling to act or to continue to act as my Executor and Trustee then, I appoint one of the following persons, in the following order of priority, as my Executor and Trustee, each individual to be appointed in the event that the individual named before him shall have died before the trusts hereof shall have terminated or shall be unable or unwilling to act or to continue to act, namely, my son, JASON CORBEE DUTCHBURN, my brother, RAYMOND DUTCHBURN, or my cousin, DOROTHY FOSTER. References to "my Trustees" in this my Will shall include each Executor and Trustee of my Will, my estate or any portion thereof who may be acting as such from time to time whether original or substituted and whether one or more.
- III. I GIVE all my property wheresoever situate, including any property over which I may have a general power of appointment, to my Trustees upon the following trusts, namely:
  - (a) To pay out of and charge to the capital of my general estate my just debts, funeral and testamentary expenses and all income taxes, estate, inheritance and succession duties or taxes whether imposed by or pursuant to the law of this or any other jurisdiction whatsoever that may be payable in connection with any property passing (or deemed so to pass by any governing law) on my death or in connection with any insurance on my life or any gift or benefit given or conferred by me either during my lifetime or by survivorship or by this my Will or any Codicil hereto and whether such duties or taxes be payable in respect of estates or interests which fall into possession at my death or at any subsequent time; and I hereby authorize my Trustees to defer, commute or prepay any such taxes or duties. This direction shall not extend to or include any such taxes that may be payable by a purchaser or transferee in connection with any property transferred to or acquired by such purchaser or transferee upon or after my death pursuant to any agreement with respect to

- (c) In the event that my wife, KATHRYN ANN DUTCHBURN, predeceases me, or survives me and dies within a period of thirty (30) days, to pay and transfer the residue of my estate to my son, JASON CORBEE DUTCHBURN, if he survives me, for his own use absolutely.
- (e) If my wife and my son both predecease me, to divide the residue of my estate among my issue alive at the date of my death in equal shares per stirpes.
- IV. SUBJECT AS MAY BE SPECIFICALLY provided herein, if any person should become entitled to any share in my estate before attaining the age of majority or while under any other disability, the share of such person shall be held and kept invested by my Trustees, and the income and capital or so much thereof as my Trustees shall, in their absolute discretion, consider necessary or advisable shall be used for the benefit of such person until he or she attains the age of majority or is no longer under such disability when such share or the amount thereof remaining shall be paid or transferred to him or her, or should such person die before attaining the age of majority or while subject to such disability, to his or her legal personal representatives.
- V. I AUTHORIZE my Trustees to make any payments for any person under the age of majority or who is otherwise under a legal disability to a parent, guardian or committee of such person or to any other person my Trustees may consider to be a proper recipient therefor whose receipt shall be a sufficient discharge to my Trustees.

MY TRUSTEES may make any division of my real or personal estate or set aside or pay VIII. any share or interest therein either wholly or in part in the assets forming my estate at the time of my death or at the time of such division, setting aside or payment, and I expressly will and declare that my Trustees shall in their absolute discretion fix the value of my estate or any part thereof for the purpose of making any such division, setting aside or payment and the decision of my Trustees shall be final and binding upon all persons concerned, notwithstanding any fluctuation in market value and notwithstanding that one or more of my Trustees may be beneficially interested in the property or any part thereof so valued.

IX. I AUTHORIZE my Trustees to make or refrain from making, in their absolute discretion, any elections, determinations, and designations permitted by any statute or regulation enacted by the Parliament or government of Canada, by the legislature or government of any province of Canada, or by any other legislative or governmental body of any other country, province, state or territory, and such exercise of discretion by my Trustees shall be conclusive and binding upon all the beneficiaries hereof. Specifically, and without limiting the generality of the foregoing, my Trustees are empowered to make any election or elections contemplated by or provided for in subsection 104(5.3) of the *Income Tax Act* (Canada), or any similar or successor section (an election to defer the deemed "disposition day") and subsection 104(14) of the Income Tax Act (Canada), or any similar or successor section (a "preferred beneficiary election"), as they in their absolute discretion consider to be in the best interests of my estate as a whole or to be in keeping with the purposes of this my Will. In making any preferred beneficiary election, my Trustees shall not be required to maintain an even hand between the beneficiaries of this my All M

Will. No preferred beneficiary election shall be construed or interpreted as an exercise by my Trustees of a discretion to pay out, allocate, or set aside any of the net annual income derived from my estate, except for the limited purposes of the *Income Tax Act*, and no beneficiary shall have any additional right or interest (other than provided for elsewhere herein) in any income which is the subject of a preferred beneficiary election by reason of such election. In addition to their power herein to make a preferred beneficiary election, my Trustees are hereby granted a separate and substantive power to make any such preferred beneficiary election on behalf of any beneficiary who is a minor.
