

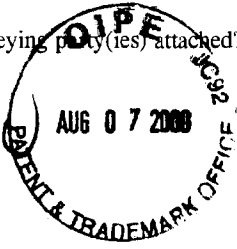

**RIGHT-HAND TUB SURROUND**


which is set forth in an application for Letters Patent in the United States, Serial No.: 29/123,330; Filed: May 16, 2000;
