WHEREAS, CHRISTOPHER C. RUTTER, a resident of Oakland, California, and ROBERT A. BILBREY, a resident of Orinda, California, and WILLIAM CHARRON, a resident of Fremont, California, hereinafter referred to as "Assignors," have invented certain new and useful improvements as described and set forth in an application for Letters Patent of the United States entitled DUAL CHANNEL BAG FILLING MACHINE WITH A CLEAN-IN-PLACE SYSTEM THAT CLEANS ONE CHANNEL WHILE THE OTHER CONTINUES TO FILL BAGS, filed with the U.S. Patent Office on April 2, 1996 under Serial No. 08/631,683 now Patent No. 5,690,151 issued November 25, 1997, and a divisional application being granted on September 22, 1998 as Patent No. 5,810,059;
