WHEREAS, We, JOHN E. NASH, WILLIAM T. FISHER, H. MICHAEL CUNNINGHAM and GREGORY WALTERS, residing at 1201 N. Chester Springs Road, Chester Springs, PA 19425, 9 Dieber Road, Schwenksville, PA 19473, 205 Merlin Road, Phoenixville, PA 19460 and 513 Swedesford Road, Malvern, PA 19353, respectively, have made a certain new and useful invention in DEVICE FOR CONNECTING A CATHETER OR OTHER TUBULAR MEMBER ONTO A GUIDE-WIRE WITHOUT ACCESS TO THE ENDS OF THE GUIDE-WIRE, and have applied for Letters Patent of the United States based thereon on March 10, 2000, which application was assigned Serial No. 09/523,077;


