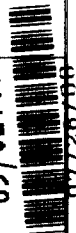

STATIC RANDOM ACCESS MEMORY BACKUP


which is set forth in an application for Letters Patent in the United States executed on even date herewith; Attorney Docket No. 60,130-835.


