

### ASSIGNMENT

WHEREAS, STMicroelectronics S.r.l. (hereinafter referred to as ASSIGNOR), a corporation of Italy, having a place of business at Via C. Olivetti, 2, I-20041 Agrate Brianza, Italy, is the owner of record of an invention entitled "INTEGRATED CIRCUIT WITH SWITCHED CAPACITOR," as described and claimed in the specification for which an application for United States letters patent was filed on November 13, 1998, assigned Application No. 09/191,560, and claiming priority based on an application filed in Germany identified by Application No. 197 50 922.3, filed November 17, 1997.

ASSIGNOR hereby authorizes and requests the Commissioner of Patents and Trademarks to issue all letters patent on said invention to ASSIGNEE. ASSIGNOR agrees to execute all instruments and documents required for the making and prosecution of applications for United States and letters patent in all countries of the world on said invention, for litigation regarding letters patent, or for the purpose of protecting title to said invention or letters patent therefor.
