
**ASSIGNMENT AND BILL OF SALE

This Assignment is subject to a Security Agreement/Pledge dated February 26, 1999, from McNiel to James H. Webb.



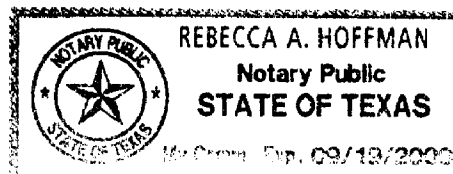
