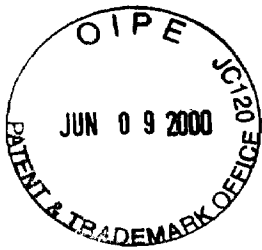

ASSIGNMENT
