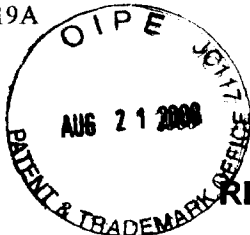

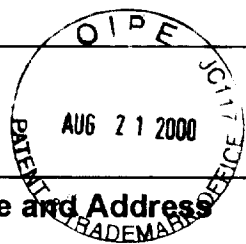

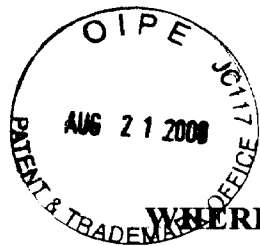

ASSIGNMENT

WHEREAS, WE, CHRISTIAN SAUTER, a citizen of Switzerland, residing at LAHMERSTRASSE 10, CH-8247 FLURLINGEN, SWITZERLAND; and BEAT BÜHLER, a citizen of Switzerland, residing at TÖSSSTALSTRASSE 263, CH-8405 WINTERTHUR, SWITZERLAND (hereinafter referenced as ASSIGNORS), have invented a certain new and useful invention entitled GRINDING OF CARD CLOTHINGS, for which an application for Letters Patent of the United States has been filed in the United States Patent and Trademark Office;



And we hereby agree to transfer a like interest, upon the request of said ASSIGNEE, its successors, assigns and legal representatives, and without further remuneration, in and to any improvements, and applications for patent based thereon, growing out of or related to the said invention; and to execute any papers by the said ASSIGNEE, its successors, assigns and legal representatives, deemed essential to ASSIGNEE's full protection and title in and to the invention hereby transferred.

Agreeing furthermore, upon request of said ASSIGNEE, and without further remuneration, to execute any and all papers desired by said ASSIGNEE for the filing and granting of applications and the perfecting of such right, title, and interest thereto in said ASSIGNEE.


