

ASSIGNMENT OF LICENSE RIGHTS UNDER U.S. PATENTS

NOW, THEREFORE, in consideration of One Dollar (\$1.00) and other good and valuable consideration, the receipt and adequacy of which is hereby acknowledged, EPIX hereby sells, assigns, transfers and conveys unto SCI, its successors and assigns, all right, title and interest in, to and under the PCC License, including but

not limited to any and all license rights of EPIX under the '459 Patent, and any divisions, continuations, continuations-in-part, reissues, renewals, reexaminations, and extensions thereof, whether issued, pending, to be filed, or to be issued.
