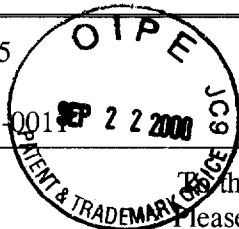

RUBBER BONDED ANCHOR PIN


