ASSIGNMENT

AND I HEREBY covenant that I have full right to convey the entire interest herein assigned, and that I have not executed, and will not execute any agreement in conflict herewith.

AND I HEREBY further covenant and agree that I will communicate to the assignee herein, its successors, legal representatives and assigns any facts known to me respecting said improvements, and testify in any legal proceedings, sign all lawful papers, execute all divisional, continuing and reissue applications, make all rightful declarations, and generally do everything possible to aid the assignee herein, its successors, legal representatives and assigns in obtaining and enforcing proper patent protection for said improvements in the United States.
