ASSIGNMENT OF INVENTION

WHEREAS, KAY (KRESL) VANDENBARK, residing at 549 Valley Forge Trail, Rockton, IL 61072, and CAMILLE (HIGGINS) ADEL, residing at 832 Cambridge Drive, Janesville, Wisconsin 53545, along with co-inventor TIMOTHY GERRISH, have made a certain new and useful invention described in a patent application filed on May 30, 1995, assigned serial number 08/453,423 and issued into U.S. Patent No. 5,601,861 entitled METHOD OF MAKING BATTERED AND BREADED FOOD COMPOSITIONS USING CALCIUM PECTINS.

thereafter, in and to said application for Letters Patent and any and all Letters Patent and extensions thereof, of the United States and countries foreign thereto which have been or may be granted on said invention or any part thereof, or improvements thereon or on said application, or any divisional, continuation, continuation in part, renewal, reissue or other application and all international priority rights associated therewith, based in whole or in part thereon, or based upon said invention, or any improvements thereon, TO BE HELD AND ENJOYED BY KERRY INC., and its legal representatives and assigns to the full ends of the terms for which said Letters Patent, or any of them, have or may be granted as fully and entirely as the same would have been held and enjoyed by us had no sale assignment of said interest been made; and We do hereby authorize and request the Commissioner of Patents and Trademarks to issue any and all Letters Patent which may be granted upon the patent application filed May 30, 1995, and assigned serial number 08/453,423 to, or upon said invention or any part thereof, or upon any improvements thereon which may be made, conceived or acquired by us during the course of our association with Kerry Inc., and for one year thereafter, to Kerry Inc., as aforesaid, and We hereby agree for ourselves, our heirs, executors and administrators, to execute without further consideration any further legal documents and any further assignments and any releases, reissues, renewals or other applications for Letters Patent that may be deemed necessary by Kerry Inc., fully to secure to Kerry Inc. its interest as aforesaid in and to said invention or any part thereof or any improvements thereon, and in and to said application for Letters Patent and the said Letters Patent, or any of them.

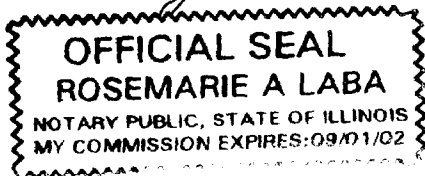
