AND General Signal Corporation requests the Commissioner of Patents and Trademarks to issue any Letters Patent of the United States which may be issued for said inventions to said Edwards Systems Technology, Inc., its legal representatives, successors or assigns, as the sole owner of the entire right, title and interest in and to said patents and the inventions covered thereby.
