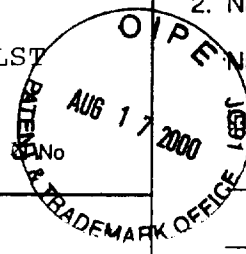

WHEREAS we, Dirk Vandenbroucke, Kathy Elst and Gina De Lamper, respectively have made a certain new and useful invention as set forth in an application for United States Letters Patent executed by us the 27th day of November 1998 for "A photosensitive image-forming element containing silver halide crystals which are internally modified with a metal ligand complex forming deep electron traps" filed on January 29, 1999 under Serial No. 09/239,705 the hereinafter named assignee being hereby authorized to insert the said serial number and filing date when ascertained;

And we request the Commissioner of Patents to issue any Letters Patent of the United States which may be issued for said inventions to said AGFA-GEVAERT its legal representatives, successors or assigns as the sole owner of the entire right, title and interest in and to said patent and in the United States in and to the invention covered thereby.
