ASSIGNMENT OF UNITED STATES PATENT APPLICATION

WHEREAS, I, **Adrian Shields** of Fife, United Kingdom (hereinafter called "the inventor(s)"), have invented certain new and useful improvements in **PORTABLE TERMINAL**, Docket No. **8490.00** (hereinafter called "the invention"), for which I have executed an application for Letters Patent of the United States of America (hereinafter called "the application") on 8-22-2000; and

WHEREAS, NCR Financial Solutions Group Limited and NCR Corporation have authorized and requested my/our executing the application; and

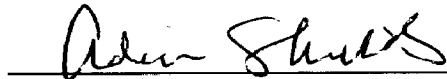

FURTHER, I, the inventor(s), and NCR Financial Solutions Group Limited hereby authorize and request any Letters Patent arising therefrom in the United States of America be issued to NCR Corporation, its successors and assigns.

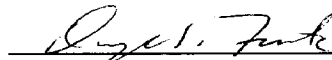

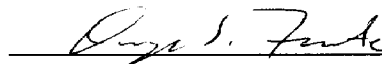
