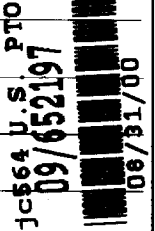


ASSIGNMENT OF INVENTION

WHEREAS, Ronald A.
