protection on said invention in all countries, without further compensation, but at the expense of PPG INDUSTRIES OHIO, INC. and TRACO, their successors, assigns, or other legal representatives.


AND I HEREBY AUTHORIZE AND REQUEST the Commissioner of Patents and Trademarks to issue any and all Letters Patent of the United States for said invention, or resulting from said application, or from any division, reissue, or extension thereof, to PPG INDUSTRIES OHIO, INC. and TRACO, as joint assignees.
