We hereby authorize and request the Patent and Trademark Office officials in the United States of America and the Patent Office officials of any and all foreign countries to issue any and all of said Letters Patent, when granted to said ALLGAIER WERKE GmbH, as the assignee of our entire right, title and interest in and to the same, for the sole use and enjoyment of said ALLGAIER WERKE GmbH, its successors and assigns.



said Letters Patent, reissues or extensions.


