



In accordance with the agreement between Beacon Laboratories, Inc. (BEACON), Bar-Ilan Research & Development Co., Ltd. (BAR-ILAN) and Mor Research Applications, Ltd., (MOR) set forth in the letter of October 9, 1997 by the late Mr. Herbert Grossman, and as set forth in the Amendment of Agreement,
