ASSIGNMENT

We hereby authorize and request the Patent Office officials in the United States and any and all foreign countries to issue any and all of said Letters Patent, when


granted, to WING INFLATABLES, as the assignee of our entire right, title and interest in and to the same, for the sole use of WING INFLATABLES, its successors and assigns.
