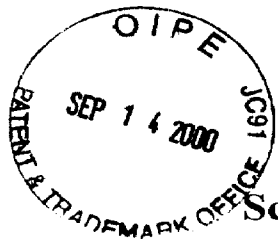

Release of Security Interest

Whereas Greyrock Business Credit, a division NationsCredit Commercial Corporation ("GBC"), having a mailing address of 10880 Wilshire Blvd., Suite 950, Los Angeles, California, 90024, and Mpath Interactive, Inc. ("Mpath") having a mailing address of 665 Clyde Avenue, Mountain View, California, 94043, did enter into a Loan and Security Agreement dated July 29, 1998 ("Loan Agreement"), a Patent and Trademark Security Agreement dated July 29, 1998 ("Security Agreement"), and a Supplement One to Patent and Trademark Security Agreement dated December 1, 1998 ("Supplement");

Whereas Mpath has satisfied all of its obligations and paid all of the debt secured under the Loan Agreement, that has now been terminated:

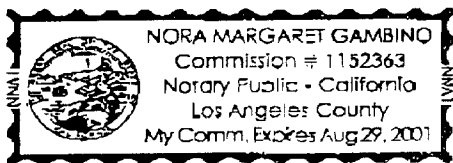
GBC, for One Dollar and/or other good and valuable consideration, does hereby release and discharge the Security Interest including without limitation

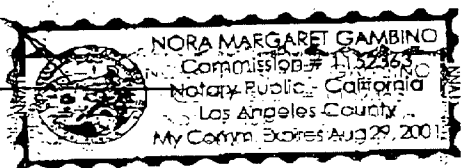
