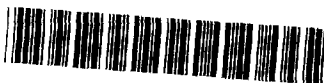

hereafter referred to as "THE UNDERSIGNED", have made an invention entitled Method of improving radio connection quality

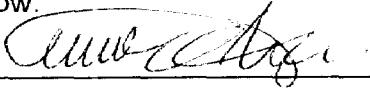
