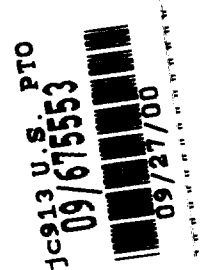



# ASSIGNMENT




