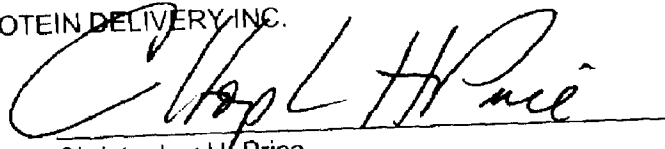
"The name of the corporation is Nobex Corporation."

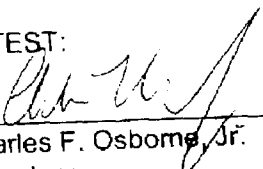
