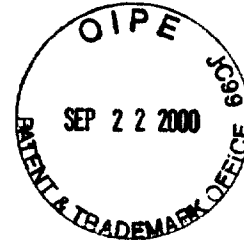

## ASSIGNMENT

WHEREAS, Richard Sutherland, John Sappington, Donna M. Brandelik, Stephen A. Siwecki, Christina K. Shepherd (nee Wendel) and Robert T. Pogue (referred to as "ASSIGNOR") have invented certain new and useful improvements in an invention entitled A SYSTEM AND METHOD FOR REPLICATING VOLUME HOLOGRAMS,

- for which a utility application for a United States Patent was filed with the United States Patent and Trademark Office on May 24, 2000, Serial Number 09/577,166.
