3. **RECITALS:**

- a) A United Kingdom patent application has been filed on 8th October 1997 and ascribed patent application number 9721286.4 for an invention entitled "Novel Clip".
- b) By an Agreement coming into effect as of the date of filing of the application the Assignor has agreed to assign to the Assignee all property rights of the Assignor arising out of the patent application including the rights in and arising out of any corresponding convention priority claiming application such as International or European patent application including all ensuing National phase patent applications.
- c) The parties now desire to confirm that agreement by formal assignment for the consideration of £1 (one pound) Sterling.


