WHEREAS, We, Gary R. DelDuca, Alan E. Deyo, Vinod K. Luthra, Wen P. Wu, have invented certain new and useful improvements in the following "Modified Atmosphere Package" for which we have made application for United States Letters Patent, and;

WHEREAS, Pactiv Corporation, a corporation organized and existing under the laws of Delaware, having its principal place of business at 1900 West Field Court, Lake Forest, Illinois 60045 (hereinafter referred to as "ASSIGNEE"), is desirous of acquiring our entire right, title and interest in and to the invention, and in and to the said application and any Letters Patent that may issue thereon;
