WHEREAS, Frank Sacca, hereinafter sometimes referred to as "said inventor," has invented certain new and useful improvements in a **SURGE PROTECTION FOR A DATA ACCESS ARRANGEMENT**, which invention or inventions (hereinafter referred to as "invention") have been disclosed to and filed, under Docket No. **00CXT0030C**, in the patent files of his employer, CONEXANT SYSTEMS, INC., 4311 Jamboree Road, Newport Beach, California 92660, and which invention will be covered by a patent application having Serial No. 09/676,742 and was filed on September 29, 2000.
