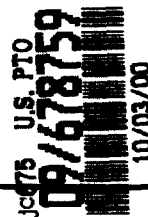

### Sole Inventorship

WHEREAS, Lars Jespersen, hereinafter call the "Assignor", has invented a new and useful TRANSMITTING AND RECEIVING CIRCUIT FOR ULTRASONIC FLOWMETER, for a full description of which reference is here made to an application for Letters Patent of the United States executed by him on even day herewith; and

And the Commissioner of Patents and Trademarks is hereby authorized and requested to issue Letters Patent to the said Assignee in accordance with the terms of this assignment.
