

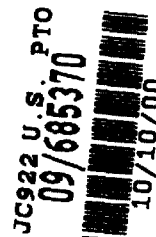

 for which Assignor is about to make United States application for patent; and


