1. I am the sole inventor of U.S. Patent No. 5,601,488, issued 2/11/97, entitled Electronic Rummy Game. By assignment dated December 30, 1996, I assigned the application which matured into this patent (S.N. 08/336,271) to Kadlic Gaming Group, Inc., a Nevada corporation. This assignment is recorded in the assignment records of the United States Patent and Trademark Office at Reel 8288, Frame 0824.

2. By assignment dated June 18, 1998, Kadlic Gaming Group, Inc., assigned U.S. Patent No. 5,601,488 to Kadlic Gaming Holdings, Inc., a Delaware corporation. This assignment is recorded in the assignment records of the United States Patent and Trademark Office at Reel 9306, Frame 0545.

3. On February 3, 1997, I filed application Serial No. 08/794,291, entitled Electronic Rummy Game Apparatus, as a continuation-in-part application of Serial No. 08/336,271 referred to above. This application matured into U.S. Patent No. 5,853,325, issued December 29, 1998.

4. The invention described and claimed in U.S. 5,853,325 was part of the invention described in parent case S.N. 08/336,271 (U.S. 5,601,488). All rights to U.S. 5,853,325 and the invention described therein were assigned to Kadlic Gaming Group, Inc., by the assignment dated December 30, 1996 referred to above, and subsequently to Kadlic Gaming Holdings, Inc., by the assignment dated June 18, 1998, also referenced above.
